# **Jasper Progressive Science Foundation (JPS)**

# 156 B., New Basti (Kali Mandir Road), Bahadurpur Ballia, 277001 (U.P.)

(This Trust Document shall be effective from the date of registration under the Indian Trust Registration Act).

 Name of the Trust- This trust will be known as Jasper Progressive Science Foundation.

# 2. The working area and office of the Trust-

The entire area which is required to give a concrete form to the objectives will be included in the working area of the Trust. The head office of the Trust will be 156-B Naya Basti (Kali Mandir Road), Bahadurpur, Ballia (U.P.).

#### 3. Trust Property-

Founder Trustee Dr. Bhagwat Prasad son of Late Sahdev Prasad declares that Rs. 10000/- (Ten Thousand) cash which is being invested and in addition will be converted, transferred in future or will be donated from time to time in any form in the form of movable or immovable wealth to any person, government, society, class trust or in a legal manner, will be considered the fund of the trust. Money received in the form of contracts, declarations, assurances will be considered included in the fund only after it is actually received.

Note- Any such amount which will be received for any contract or Memorandum of Understanding (MoU) or for joint expenditure for any specific purpose will not be considered the fund of the trust, until its remaining / any part is not directly donated to the trust fund because such money will be functional in nature.

#### 4. Ownership of property-

The properties of the Trust shall be deemed to be entrusted under this document, over which the Trust shall have the ownership, and along with managing it completely, it shall be able to spend the income of dividend, rent and securities in the Trust Fund as per the approved work plan without any discrimination on the basis of religion, caste, class, colour, area and sex and shall be able to determine the expenditure at its discretion as per the document.

#### 5. Objectives of the Trust-

- To promote, conduct and organize every kind of work of human welfare in addition to cultural, literary and social work.
- 2. To conduct research to find out the factors of various types of social, economic and educational development and to take financial and non-financial advice and support from the Government of India and State Governments as well as from the expatriate, Indian and other non-Indian individuals and institutions.
- 3. To provide opportunities to benefit from various art and cultural programs, functions, meetings, camps, seminars and knowledge and experience of invited experts for public awareness and to promote conservation, reconstruction and research of related heritage.
- 4. The objective of the Trust is to make the society healthy, to make people aware of healthy living and to inspire them to adopt a healthy lifestyle and to provide practical training.
- 5. Jasper Progressive Science Foundation (SPSF) To discover human talent for the development and progress of India and to ensure proper use of their energy in all activities free from the prejudice of sex, caste, community or language. For which the following objectives can be there-

- (i) The Trust will publish research journals like Journal of Progressive Science and other journals, magazines, books, bulletins, periodicals covering various subjects/research/achievements in life sciences, social sciences, natural sciences etc. under its ownership and will publicize the objectives, programs and achievements of the Trust through exhibitions, films, papers, information etc.
- (ii) To organize and participate in seminars, conferences, exhibitions, fairs, training programmes, publication of literature and other publicity material on natural and biological sciences and other subjects at national, international and regional level.
- (iii) The Trust will assist and guide its members and associates in obtaining technical and financial assistance from Governmental, Governmental, Corporate, Non-Resident Indian, Bilateral or Multilateral contracts that they so can ICAR,ICMR,CSIR,UGC,UPCAR,UPCST,DST,DBT World Bank, UNDP, ADB, WHO, UNICEF, FAO etc. can get contact and help from organizations providing financial and technical support.
- (iv) To conduct research in the context of information obtained from techniques related to biological and natural sciences and modern science.
- (v) To conduct and promote research under the joint supervision of UGC,ICAR,CSIR,ICMR,NCTE etc. towards upgrading the educational level in various fields of social, agriculture and science by sponsoring through appropriate means programmes developed by professional researchers and private agencies.

- (vi) To encourage the rural population to use modern technology for higher production and lower cost in agriculture, horticulture, animal husbandry, fisheries, poultry farming, beekeeping and cottage industries and business etc.
- (vii) To undertake research towards enhancing science and technology in selection of suitable areas for agricultural products.
- (viii) The Trust will establish information centres, research centres, libraries, institutes, organisations with necessary facilities to fulfil its objectives.
  - (ix) To prepare plans for rural development involving collaboration between all activities and resources that may be sponsored through State, Central and International voluntary agencies, professional organizations.
  - (x) Along with helping the people of the disaster affected areas, moving forward towards expanding irrigation facilities, increasing soil fertility and proper management of water conservation.
  - (xi) To be committed to the socio-economic development of the rural and urban areas of Uttar Pradesh.
- (xii) To organize information and awareness programmes in rural areas by sponsoring farmer fairs and training centres on issues related to food adulteration, environmental protection, diversified agriculture, family welfare, problems of women and vulnerable persons.
- (xiii) To establish educational institutions, libraries, training centres and agricultural safety centres for the rural masses so as to raise their standard of living and to establish food production analysis laboratories, soil testing laboratories, technical consultancy, plant

protection, food processing, technical testing centres for their use after harvesting.

- (xiv) To promote entrepreneurship development by implementing schemes and programmes for developing small and agro-based home industries.
- (xv) To fulfil its objectives the Trust shall acquire any movable or immovable property by rent or sub-lease, permission, gift, purchase, exchange contract or any other means and may take effective steps towards achieving its objectives by construction, repair, alteration, development and protection of those buildings as per requirement along with demolishing, reconstructing or getting them managed, developed and given on rent to others or by selling or mortgaging the entire or partial property.
- (xvi) The Trust will gratefully accept monetary grants, equipment, land, building, donations, gifts, contributions or other assistance received in fulfilment of the objectives of the Trust whether from the Government of India, State Government or from any agency based on international multilateral or bilateral agreements, or from any grant, payment or assistance received or given on the basis of resource or affiliations.
- (xvii) To achieve its objectives the Trust will adopt new relationship management and financial proposals.
- (xviii) To fulfil its objectives the Trust may cooperate and collaborate with the Government of India, State Government or other authorized organizations, institutions or sponsored commissions, councils as well as international organizations, institutions and foreign institutions.

- (xix) The Trust shall, on its own, represent the State at regional, national and international conferences, meetings, seminars and events and may receive scholarships, fellowships, prizes and medals and certificates of achievement and commendation.
- (xx) The Trust will confer honorary degrees on distinguished personalities who have achieved excellence in national and international fields and highlight their outstanding work.
- (xxi) Apart from these the Trust will do all such works which are considered useful for achieving the objectives of the Trust.

#### 6. Number of Trustees-

The total number of all types of trustees in this trust shall be minimum 05 and maximum 21.

# 7. Types of Founder Trustees-

Dr. Bhagwat, son of late Sahdev Prasad, is the founder trustee of this trust who will be the lifelong president of the trust.

# 8. Honorable Member-

The Board of Trust may, by law, declare persons having special achievements, talent or creative work in social, educational, literary, cultural, scientific or other fields as its esteemed Trust members and honour them on special occasions by means of various medals/certificates of appreciation/honorary titles.

#### 9. Privileges of the Founder Trustee-

If the Founder Trustee wishes, he can be the Chairman of the Trust for life. He will have the final authority to determine and amend the programs of the Trust. He will have the right to give approval/consent before implementing the proposals and decisions of the Trust Board or the working committees of various names and forms operating/formed under this document and to reject them if found contrary to the objectives. He will have full authority to inspect and give appropriate directions either on his own or on request regarding the activities, programs and persons involved in the Trust.

#### 10. Powers of the Chairman of the Trust-

- (i) In case of absence of the Chairman of the Trust due to any reason, the Board of Trustees shall appoint one of its trustees as the Acting Chairman who shall hold the post till the new appointment. The Acting Chairman (Adhyaksh) shall preside over all the meetings.
- (ii) The Chairman may appoint a maximum of five persons to the Board of Trustees as per the requirement whose term shall be five years but he may reappoint or change them as per his discretion.
- (iii) If there is equal division of votes in the matters of management of the funds of the Trust, discretionary powers or decision, then the additional vote of the Chairman shall be decisive.

- (iv) The Chairman shall be authorised to receive the amount of money which he receives while representing the Trust as remuneration and allowance for acting as any other advocate, mediator, accountant or agent.
- (v) In the absence of the Chairman, the Vice Chairman shall act as the Chairman.

#### 11. Powers of the Trust Board-

- (i) The Trust Board will be authorized to form Board of Trustees, Working Committee, Advisory Committee, Fund Management Committee, Directors Committee, Investment Committee, Fund Promotion Committee with various names as per the objective and can also enter into contracts for this purpose.
- (ii) The Trust Board will nominate members for financial management and audit, who will be authorized to work as per the objective of the Trust.
- (iii) To give approval for compliance with the decisions of the Trust Board and approve/sanction all types of expenditure.
- (iv) The Chairman will appoint all the office bearers as per the requirement for a maximum period of 5 years, who can also be re-appointed.

#### 12. Meetings

There will normally be two meetings in a year, apart from which if any other meeting is held, it will be treated as a special meeting. The Secretary/Joint Secretary will provide information to the trustees 15 days in advance about the meeting to be held at the prescribed time and place with the consent of the Chairman/President.

#### 13. Quorum

The quorum for the meeting of the Trust will be 1/2 of the trustees which will be calculated at the prescribed time, but it can be rescheduled even one hour after that, for which there will be no obligation of quorum.

## 14. Resignation or removal of a trustee-

- (i) Any trustee can take leave or resign by giving written notice to the Chairman.
- (ii) Before removing any trustee, a show cause notice will be given after giving him an opportunity of 15 days and if necessary, he can also be removed from the membership by a resolution of the Trust Board. The charge sheet will be issued by the Chairman/Secretary or his authorized person.

## 15. Rights of the Secretary-

- (i) The Secretary of the Trust shall discharge all the functions and responsibilities on behalf of the Trust.
- (ii) He shall discharge the rights, duties and responsibilities mentioned elsewhere in this Trust document.
- (iii) He shall do all the correspondence on behalf of the Trust and shall safeguard the establishment of the Trust office, the proceedings of the Trust and all the documents of the Trust.
- (iv) He may authorize any person to do or get done all the works of the Trust.
- (v) As per the decisions of the Trust Board, the Secretary or a person authorized by him may, after the consent of the Chairman, do the right to purchase and sell movable and immovable properties including Memorandum of Understanding (MoU) on behalf of the Trust.
- (vi) The Joint Secretary shall have the right to assist the Secretary in his work and to perform the work of the Secretary in his absence.

#### 16. Financial Year of the Trust-

The financial year of the Trust shall be from 1st April to 31st March of the following year.

#### 17. Trust Fund and its Investment-

- (i) The Board of Trustees shall be authorised to open, operate and maintain permanent deposit account/current account/savings account or any other account in the name of the Trust from time to time in banks which shall be operated jointly by the Chairman and Secretary and shall have the right to deposit or pay/transfer and withdraw all receipts in the name of the Trust. It shall also have the right to accept income received on deposits or in any other form. The Trustees shall pass resolutions for operating the bank accounts.
- (ii) As per the applicable rules with the prior consent of the Chairman, the original Trustees alone shall have the final and absolute right to acquire immovable property or movable property and to sell them either wholly or partly for the benefit/development of the Trust. The original Trustees shall also have the absolute and absolute right to exchange, transfer and let on rent all movable and immovable properties wholly or partly by public auction, personal contract or in any other manner.
- (iii) Decisions taken by the original trustees regarding purchase, sale or transfer of immovable properties in any other manner will be independent of profit and loss. No other trustee will be personally responsible for any kind of loss due to purchase and sale.
- (iv) The loan, security, payment, mortgage or any other type of financial liability given by the trustees from time to time in their discretion in favour of the trust, which will be included in the trust fund, will be considered legal.
- (v) Three trustees authorized by the Trust Board will be authorized to perform all the tasks, who will also be responsible for protecting the trust fund from loss.

#### 18. Rights of Trustees-

- (i) For the benefit of the trust, the trustees will have the right to receive or pay money from anyone under fiduciary relations at their own discretion or through any agent or bank.
- (ii) The trustees will have the right to execute/resolve any accounted cases, enter into, cancel or abstain from contractual relations in the interest of the trust.
- (iii) The trustee will present the details of financial contracts and settlements made at his level in the meeting of the Board of Trust, on which approvals/disapprovals will be proposed and disposed after consideration. The works of the trustees in the interest of the trust will be considered as the work of the trust.
- (iv) The trustee will be authorized to receive the amount which is given to him as remuneration and allowance for working as any other advocate, mediator, accountant or agent while representing the trust.

#### 19. General Provisions-

- (i) The rights, ownership, acquisition, possession or other financial powers of the original trustees of this document over the trust fund which are related to issuing, ending or relinquishing any part of the fund will remain forever and cannot be withdrawn.
- (ii) The vote expressed by the trustees in the trust board will not affect the proposals decided by the majority, and will be binding on all the trustees in minority.
- (iii) If the secretary or special executive person for the operation/benefit of the trust fails in any work or is absent due to any reason, then it can be done through/with the signature of other trustees.

- (iv) The trustees will be authorized to establish centers, offices, institutions in various forms with various names at different places, separately or jointly, and establish management under the chairman and operate/manage/establish them.
- (v) All the trustees of the trust will be honorary but they will be entitled to allowances for trust work.
- (vi) The Indian Trust Act 1882 and Section 2(41) and 80(g) of the Indian IncomeTax Act will be applicable to the Trust.
- (vii) The Trust will be authorized to receive grants, assistance, movable and immovable property from persons, organizations, departments, or institutions within and outside India for enriching its funds and to get exemption for such donors under other laws including the Income Tax Act and to get registered under the Foreign Exchange Regulation Act.
- (viii) The entire functioning of the Trust will be done by resolutions passed in the meetings and the Board of Trustees will be accountable to the Trust.
  - (ix) In the absence of any other arrangement of the Board of Trustees, the Secretary himself or a person authorized by him will manage the Trust's office, Trust program management and all records with the cooperation of the Trust and remuneration will be payable.
  - (x) Differences will be resolved by mutual consent. Disputes will be resolved under the District Ballia, Uttar Pradesh Tribunal.
  - (xi) The treasurer of the trust can keep approximately Rs. 5000.00 (five thousand) in cash with him for contingency expenses and will be responsible for complete accounting.
- (xii) This trust document can be translated into other languages as per the requirement.

- (xiii) The trust will not be responsible for the personal transactions and criminal activities of any trustee.
- (xiv) In case of objection, any person who is insane, bankrupt, person concealing facts, person receiving salary from public funds, criminal, or any person involved in activities against the trust will not be able to remain a member of this foundation.
- 20. Separate management committees will be formed for schools/secondary-Schools/colleges, research institutes, laboratories or other purposes established by the Trust for which the lists of the General Body will be separate in which all the members falling under rule 6 and 7 of this document will be included who will have the right to elect and form management committees as per the relevant Government rules. Before each new election, the list of the General Body will be issued by the Secretary of the Trust.

#### 21. Rule-Making-

The Trust Board will be authorized to make rules/regulations for all its subordinate offices, centres, institutions, departments or divisions and to implement and amend them from time to time, which will be considered legal, if all the provisions are not contrary to the basic spirit and objectives of the Trust Document.

#### 22. Amendment in documents-

2/3rd of the Trustees of the Trust Board will have the right to amend/change this Trust Document or any/part of its provisions as per the requirement, but for this, a special meeting will be called by specially informing the Trustees two weeks in advance through registered post.

#### 23. Winding up of the Trust-

24. The movable and immovable property of the Trust will not go to any member of the Trust Board in any case in the event of winding up, rather it will be transferred to any trust and institution with similar objectives or any public authority, free from all liabilities. For which the order of the Income Tax Commissioner will be required. This document will be revocable by the founding trustee.
